**PLEASE NOTE:**

1. No dogs under twelve (12) months of age will qualify for a "V" grading.
2. Entries postmarked on or prior to the closing date will be accepted provided that they are received within five (5) days of the closing date. Late entries will be returned. Entries without proof of payment, marked RAF or TAF will not be accepted. Only correctly completed official KUSA show entry forms will be accepted.
3. VETERANS (VE) for dogs of any age specified in the Show Schedule but not less than seven years of age on the day of the Show.
4. WORKING DOG CLASS (WD) for dogs with any of the following minimum qualifications: Class "A" in Obedience, CD, IPO I, TT2 or BWT. A copy of the record card must accompany the entry form.
5. NEUTERED DOG (ND) for dogs of any age that have been castrated for any reason whatsoever.
6. This show will be held under the rules and regulations of KUSA. Your attention is drawn to Schedule 3 and 5E(21).
7. The Committee reserves the right to appoint alternate officials should those advertised be unable to officiate. The Committee also reserves the right to limit the number of Breed Assessment entries.
8. Puppies under four (4) months of age are not eligible for competition.
9. No dogs may enter the ring before being positively identified by microchip. Remember to include your dog's microchip number on your entry form.
10. Entry numbers will not be posted and can be collected on the day of the show. Please send a self addressed stamped postcard / envelope if you wish to be sent confirmation of receipt of entries.
11. No animal other than an exhibit entered for competition or for exhibit shall be permitted within the precincts of a show except registered Guide Dogs for the blind, Hearing Dogs for the deaf and dogs requested for educational and instructional purposes or by the permission of the show holding club.
12. All exhibitors / handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claim which may be made in respect of injuries which may arise or be caused by their dogs.
13. Bitches in season may compete in the above breed classes. The mating of bitches within the precincts of the show is forbidden.
14. If any dog is exhibited which has been knowingly exposed to the risk of any contagious or infectious disease during the period of six (6) weeks prior to exhibition; or if any dog at a Show should be found to be suffering from any contagious or infectious disease, including any reaction to immunization, or is found to be unfit for exhibition from any other cause, the exhibitor thereof shall be liable to be dealt with under Rule 2 Disciplinary Rules (Schedule 1).
15. The Natal Rottweiler Association reserves the right to extend the show to Sunday 17<sup>th</sup> June 2018, should the Club deem it necessary. Exhibitors will be notified by 10<sup>th</sup> June 2018 should this occur. In this instance, Breed Assessments will take place on Monday, 18<sup>th</sup> June 2018.

**MRS. LETSIE FISCHER (GAUTENG)**



*I was born in January 1965, married to Johann Fischer and we have 2 children Hannes (27 years old) and Corlia (21 years old). Professionally I did my Maters degree in Biokinetics at the University of Pretoria. Currently I don't practice as a Biokinetician, but help Johann with his Engineering business and dedicate my time to our family and our Rottweilers.*

*From the time I can remember I had a dog, my first dog as a 4 year old girl was a Boerboel. In 1988 Johann and I bought our first Rottweiler after we saw a programme on television that demonstrated the Aptitude Testing (APT) of dogs. The Rottweiler stood out for me as a dog, highly trainable, intelligent, loving and devoted to his family, my all-in-one dog. The intention was never to become a breeder but seeing and experiencing the wonderful nature and character of this phenomenal breed, we decided to try to preserve that and so Boschkop Rottweilers was born.*

*We joined the Rottweiler Working and Breeding Association (RWBA) in 1989. We are breeding Rottweilers under the KUSA Kennel name "Boschkop" since 1990. In 1997 I started Puppy Socialising classes at the RWBA for the first time, at that time a very new concept in Rottweiler training. We managed the Pretoria Branch of the RWBA for many years, and I served as treasurer on the main committee for many years. In 2001 I qualified my 4,5 year old Rottie male, Boschkop Fritz as one of the first Rottweiler Canine Good Citizens (CGC) and in the same year he passed the APT test under Dudley Bennett. At that point in time CGC was an unknown area for the Rottweilers as a breed. I must admit some people frowned upon us participating. I Took him to schools and old age homes, teaching kids about responsible pet ownership and highlighting numerous elderly in old age homes.*

*In 2005 we imported 2 female Rottweilers from Europe and later a male in the quest to improve our own genetic lines and breeding. This proved to be very successful with the result of winning numerous Specialist Championship Shows Best in Show titles as well as Grand Victor titles, with them and their offspring. Our proudest are the "Home Champion Rottweilers" in loving homes, where the dogs we bred, are integrated family members. A couple of our Rottweilers we bred are qualified Therapy Dogs. We have bred 57 Rottweiler litters in 28 years.*

*I am a founder members of the Praetor Rottweiler Club of Tshwane (PRC) and have been the chairperson since its affiliation with KUSA in 2011. I head the training of the club and the reward is heart-warming to see the once scared and unsure dog and owner, developing into the self-assured, formidable and obedient team of man and his dog. I also serve on the Rottweiler Breed Council as delegate of the PRC, at first heading the "Media and Communication portfolio" but currently as the Secretary of the RBC.*

*I qualified as a Rottweiler Specialist judge in November 2015 after being involved on the learner judges' scheme of KUSA through many changes. I am currently in the final stages of qualifying as a Working Group KUSA judge. I am looking forward to judge your show. I feel very honoured and thankful for the opportunity.*

- By entering, exhibiting or handling a dog at a show held under a Kennel Union licence I agree to be bound by the KUSA Constitution (as amended) in its entirety including all the schedules thereto. (hereafter "the Constitution").
- The attendance or exhibition of a dog that has either suffered from or been exposed to any infectious or contagious disease(s) within 6 weeks prior to the show, or that is suffering from such disease(s) at the time of the show, is contrary to the Constitution. Contravention of this regulation by me may result in disciplinary action in terms of Schedule 1 Rule 2.
- This dog is entered and exhibited entirely at my own risk. Accordingly, unless specifically authorised to the contrary by a Judge, or while the dog is in the ring or carrying out any licensed event as part of the competition, or engaged in practice prior to participating in the show, I will ensure that the dog is at all times properly secured either within a suitable container or by a lead or leash that must at all times be either hand-held or securely anchored.
- I am fully responsible for my dog's safety and behaviour at all times to the extent that I accept personal liability in respect of any claim made in respect of any damage or injury caused by my dog and/or my failure to adequately control my dog. I acknowledge that my dog has the ability to cause harm to other dogs, persons or property at the show.
- I indemnify KUSA, the affiliated Club conducting this Show, and the Officers of the Club against any and all claims of whatsoever nature and whatsoever arising that may be levelled against them, jointly or severally, in respect of any harm caused by my dog and/or any failure on my part to adequately control my dog.
- I am fully responsible and liable for any harm caused to any person, animal or property arising out of any action by any minor child for whom I am legally responsible by allowing them to handle a dog for which I am responsible.
